6. STUDENT SERVICES

6.1. Special Education Update

Heather Morgan, Director of Special Education made a report which provided the Board of Trustees with program, fiscal, and staffing updates and implications for the Special Education Department. Program updates included Information about plans for inclusion, professional development, behavior support, and equity for dual-identified students.

Amy Fickenscher made a report about the Special Education District Advisory Committee (SEDAC) and focused on the IEP process, upcoming meetings & community Education events and community needs.

Trustee Proctor made a question about a specific area in our District where we could improve to retain students and suggested that perhaps creating programs and services at the district level to minimize the use of outside agencies. Trustee Proctor also requested a year to year analysis of expenditures. Additionally, she inquired on how we address the needs of transitioning from middle school to High School.
